Adolescent Dog Training Class

Terms & Conditions

Thank you for choosing to train with us! To ensure a safe, productive, and enjoyable experience for everyone, please read the following Terms & Conditions carefully.

1. Eligibility

- This course is open to adolescent dogs between 6 and 24 months of age at the start of the course.
- All dogs must be up-to-date with vaccinations, flea, and worm treatments. Confirmation may be requested.
- Guardians are responsible for ensuring their dog is fit and healthy to attend.

2. Bookings, Payments & Behavioural Policy

- Full payment is required in advance to secure your place. Spaces are limited and allocated on a first-come, first-served basis.
- Cancellations made seven or more days before the start date are eligible for a full refund or can be transferred to another date.

- Cancellations made within seven days of the start date are non-refundable, although transfers to alternative dates may be offered where possible.
- If a dog is asked to leave the course due to behavioural concerns, no refunds will be given. In such cases, private one-to-one behaviour sessions may be recommended.
- Dogs must be sociable and comfortable in public outdoor environments. This course is designed for training purposes, not behaviour modification for aggressive or highly reactive dogs.

3. Cancellations & Missed Sessions

- Missed sessions are non-refundable and cannot be carried over. Handouts and guidance will be provided where possible.
- In the event of instructor illness or unforeseen circumstances, an alternative date or credit may be offered.

4. Class Environment & Equipment

- Sessions take place outdoors in public spaces. Please dress appropriately for the weather. Trainers are not suitable on muddy ground; winter boots are recommended.
- Dogs must arrive with a harness, flat collar, and a 3-meter lead. A long line is recommended for recall exercises and should be brought along.
- A handout with any additional equipment required for each session will be sent by email once you have booked.
- Guardians are responsible for their dog's behaviour and must ensure dogs are under control at all times.

5. Behaviour & Suitability

- Dogs must be comfortable around other dogs, people, children, and common outdoor distractions such as bikes and joggers.
- Please let the instructor know if your dog has any allergies, food restrictions, or special dietary requirements.
- Fearful, reactive, or excessively barking dogs may be better suited to private sessions.
- If in doubt about your dog's suitability, please contact me before booking.

6. Guests & Children

- Groups are kept small, with a maximum of two people per dog.
- Children are welcome, but please discuss in advance to ensure group safety. Additional family members cannot attend without prior agreement.

7. Cleaning Up & Respecting the Environment

- Guardians are responsible for cleaning up after their dog at all locations.

8. Liability

- Attendance is at your own risk. While reasonable care is taken, I cannot accept responsibility for injury, loss, or damage to you, your dog, or your belongings.
- If you do not feel comfortable with any activity suggested during a session, you are under no obligation to participate.
- Please note that this course takes place outdoors in public spaces, and I do not have full control of the environment.

9. Training Methods

- Only kind, positive, reward-based training methods are used.
- Harsh handling, physical punishment, or aversive equipment (e.g., choke chains, prong collars, slip leads for control, no-pull harnesses) is not permitted and may result in dismissal from the course.

10. Photography & Social Media

- Photos or videos may be taken during sessions for training or promotional purposes. Please notify the instructor if you prefer not to be included.

11. No Smoking

- Smoking or vaping is not permitted at any session location.
